

## **TERMS AND**

## **CONDITIONS**

**1. CONTEST PERIOD:** The Contest start date is May 1, 2018 at 00:00:01 AM EST. Contest closing date is at 11:59:59 PM EST on May 31, 2018.

**2. ELIGIBILITY:** To be eligible to win the prize, an entrant must: a) be a Canadian resident; b) have reached the age of 21 as of the Contest start date; c) not be an employee of (or be domiciled with an employee of) Starsky Fine Foods Inc. or its affiliates, or contractors.
